

STATEMENT OF PROPOSAL

HAVE YOUR SAY BY 16 JANUARY 2022





BACKGROUND

In 2016, the Shop Trading Hours Amendment Act 2016 enabled local councils to develop and adopt a policy to allow shops to open on Easter Sunday. In 2017, Waikato District Council adopted an Easter Trading Policy (Policy).

The Easter Trading Policy allows shops to trade on Easter Sunday if they wish to. Without a policy, shops in the Waikato district would not be allowed to open unless they fit the criteria set out in section 4 of the Shop Trading Hours Act 1990.

The Policy is now due for review, and we would like your feedback on whether we continue to permit shops to trade on Easter Sunday from 2022.

REASONS FOR THE POLICY

- The Shop Trading Hours Amendment Act 2016 allows councils to develop a policy to allow shops to open on Easter Sunday.
- A Policy provides clarity on whether shops can open on Easter Sunday.
- The Policy enables shops in the Waikato district to open if they wish to.
- The Policy is enforced by Ministry of Business, Innovation and Employment.



Three options are outlined below.

Note: Under any option, alcohol cannot be sold through an off-license on Easter Sunday. Shops described in Schedule One of this Statement of Proposal may open as per the Shop Trading Hours Act 1990 regardless of whether or not Council develops a policy.

Option I - Status quo

Council adopts a policy that allows shops to open on Easter Sunday.

Option 2 - Restricted areas

Council could adopt a policy to enable shops to open in parts of the district. This option is not recommended due to the make-up of our district (short distances between retail centres) and would create confusion on areas that are permitted to open versus those that are not permitted to open.

Option 3 - Revoke Policy

Council could revoke the Policy. This would mean only those shops specified in section 4 of the Shop Trading Hours Act 1990 would be able to open. The type of shops included in section 4 are:

- A. garden centres
- small scale supermarket i.e. dairy
- c. shops selling souvenirs
- D. shops selling duty free goods
- E. restaurants
- F. shops at transport terminals selling souvenirs, duty free goods, restaurants and books or magazines etc.
- G. pharmacy
- H. shops at an exhibition or show



Anyone can make a submission to the review of the Waikato District Council Easter Trading Policy and we encourage you to let us know your views. This feedback will be used during the decision making process.

A submission form is included in Schedule Two of this Statement of Proposal. Instructions on how to make a submission can be found on page 6 of this document.

SCHEDULE ONE: WHAT SHOPS CAN OPEN

The table below is an extract of information (available from www.employment.govt.nz) shows those shops that are able to open regardless of whether Council adopts a policy or not. The shops below are exempt under the Shops Trading Hours Act 1990.

Is the shop a	Then they can open so long as	Conditions
Service station or dairy	The only goods they sell are: • Food • Drink • Household items • Personal items • Petrol, oil, car parts and accessories.	The goods they sell are items people can't put off buying until the next day, such as baby formula or pet food, and the number of goods for sale is no more than needed to meet the needs of people in the area.
Take away bar, restaurant, cafe	They only sell prepared or cooked food ready to be eaten immediately in the form that it is sold.	
Duty free store	They are only selling duty free items.	
Shop providing services, rather than selling goods, such as a video rental store or hairdresser	They only provide a service, such as renting videos or cutting hair.	They don't sell any goods, such as videos or hair products.
Real Estate Agency	No conditions. Real estate does not fit within the definition of goods as defined by the Act.	
Pharmacies	No conditions.	
Garden centres	The only restricted trading day they can open on is Easter Sunday.	
Shop in premises where an exhibition or show is taking place. This includes markets, craft shows and stalls at these exhibitions and shows	They only sell books, magazines and newspapers, or duty free items/souvenirs, or food that has been cooked/prepared and is ready to be eaten.	
Shop selling only souvenirs	The shop/stall must be within the building/location of an actual exhibition or show.	The exhibition or show must be devoted entirely or primarily to agriculture, art, industry, and science, or any of these. This is quite a strict requirement, and to be considered 'devoted' to a show or exhibition a shop must be selling goods that are connected in some way with the show. For example, arts and crafts at an art and craft show, or farming supplies at an agriculture show, rather than general goods.
Shop at any public transport terminal or station	The criteria for whether or not an item is considered a souvenir is quite strict. Items must be connected to a place or culture in New Zealand.
