Purpose

The Policy & Regulatory Committee is responsible for the Council's governance policies and bylaws, reviewing the District Plan and overseeing civil defence and emergency management issues.

In addition to the common delegations on page 10, the Policy & Regulatory Committee is delegated the following Terms of Reference and powers:

Terms of Reference:

1. To establish, implement and review the governance policy framework that will assist in achieving the Council's strategic priorities and outcomes.
2. To develop, review and approve the consultation process for Council bylaws.
3. To consider and determine changes to the schedules and parking restrictions in the Public Places Bylaw 2016, including hearing any submissions relating to those proposed changes.
4. To hear and determine matters arising under current bylaws, including applications for dispensation from compliance with the requirements of bylaws, unless such matters are otherwise delegated by Council.
5. To administer the Council's District Plan in accordance with the Resource Management Act 1991.
6. To monitor the performance of regulatory decision-making by the District Licensing Committee¹, Regulatory Subcommittee and officers under their respective delegations.
7. To monitor the Council's Civil Defence and Emergency Management framework.

¹ For clarity, the District Licensing Committee is a committee of Council under the Sale and Supply of Alcohol Act 2012.

The Committee is delegated the following powers to act:

Governance Policies

- Develop and agree governance policies for the purpose of consultation/engagement.
- Recommend to Council policy for adoption, amendment or revocation.
- Monitor and review policy, including recommending amendments to any policy as and when required.

Bylaws

- Develop and approve the statement of proposal for new or amended bylaws for consultation.
- Recommend to Council new or amended bylaws for adoption.

District Plan

- Review and approve for notification a proposed district plan, a proposed change to the District Plan, or a variation to a proposed plan or proposed plan change (excluding any plan change notified under clause 25(2)(a), Schedule 1 of the Resource Management Act 1991)
- Withdraw a proposed plan or plan change under clause 8D, Schedule 1 of the Resource Management Act 1991.
- Make the following decisions to facilitate the administration of plan changes, variations, designation and heritage order processes:
 - a. To decide whether a decision of a Requiring Authority or Heritage Protection Authority will be appealed to the Environment Court by the Council and authorise the resolution of any such appeal, provided such decisions are consistent with professional advice.
 - b. To consider and approve Council submissions on a proposed plan, plan changes, and variations.
 - c. To monitor the private plan change process.
 - d. To accept, adopt or reject private plan change applications under clause 25, Schedule 1, Resource Management Act 1991.

Other Resource Management Issues

- Pursuant to Section 34(1) of the Resource Management Act 1991, to exercise all of the Council's functions, powers and duties under that Act, except the functions, powers and duties:
 - a. that cannot be delegated or that are otherwise retained by the Council under its terms of reference; or
 - b. expressly delegated to other Council committees or decision-making bodies, or officers.

- Monitor and approve submissions in relation to National Policy Statements.

Civil Defence and Emergency Management

- Monitor the performance of Waikato District's civil defence and emergency management response against Council's requirements under the Civil Defence and Emergency Management Act including:
 - a. implementation of Government requirements; and
 - b. co-ordinating with, and receiving reports from, the Waikato Region Civil Defence and Emergency Management Group Joint Committee.

Other Delegations

- Exercise all of the Council's functions, powers and duties under the Building Act 2004, the Health Act 1956, and the Food Act 2014, and the respective regulations made under these Acts, except the functions, powers and duties:
 - a. that cannot be delegated or that are otherwise retained by the Council under its terms of reference; or
 - b. expressly delegated to other Council committees or decision-making bodies, or officers.
- Approval of attendance of elected members at conferences, seminars, training or events, in accordance with Council policy.

1. Purpose of the report

Te Take moo te puurongo

To present, hear and consider the submissions received on the proposed Easter Trading Policy 2022.

2. Executive summary

Whakaraapopototanga matua

The Easter Trading Policy allows businesses in the Waikato district to trade on Easter Sunday if they wish to. The policy is due for review in 2022 and was consulted on from 1 December 2021 to 16 January 2022.

During the consultation period 121 submissions were received, with 38 percent of the proposed policy in support and 61 percent not in support. 1 percent noted 'other'.

Two submitters will be speaking to their submissions on 8 February 2022.

Following the hearing and deliberations, the proposed Easter Trading Policy 2022, with any amendments, will be presented to Council on 28 February for adoption.

3. Staff recommendations

4. Background

Koorero whaimaarama

Council adopted its Easter Trading Policy (Policy) on 10 April 2017 permitting shops to trade on Easter Sunday.

The policy is required to be reviewed every five years, therefore if Council wishes to retain an Easter Sunday shop trading policy, a new policy must be adopted before 10 April 2022. In reviewing the policy, Council is required to consult with the public under section 83 of the Local Government Act 2002 regardless of whether any amendments to the policy are proposed.

A Council workshop was held on 21 October 2021 to discuss any changes to the policy. During the workshop Council did not propose any changes to the policy prior to its release for public consultation.

At the Policy and Regulatory Committee meeting on 24 November 2021, the Committee approved the proposed Easter Trading Policy 2022 for consultation.

5. Discussion and analysis

Taataritanga me ngaa tohutohu

Public consultation was undertaken to advise the public of the proposed policy and invite them to make submissions. Staff used the following communication methods:

- Public notice/media release*
- Social media
- Information to Community Boards and Committees*
- Information to Iwi*
- Council's Facebook page.

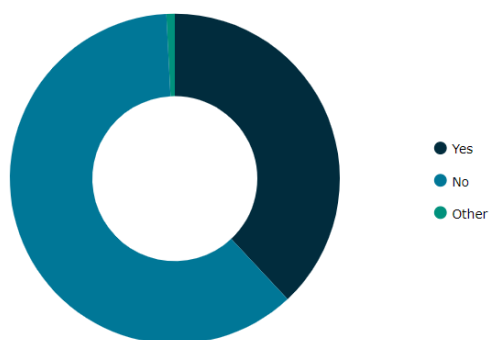
* These methods were combined with two other consultations occurring during the same period to ensure efficient communication.

The public were asked *"Do you support shops being able to open on Easter Sunday?"*

Consultation was open from 1 December 2021 and closed on 16 January 2022. A total of 121 submissions were received.

38 percent of submitters supported the proposed policy for businesses to be able to trade on Easter Sunday and 68 percent were against the proposal. 1 percent of submitters noted neither but suggested essential services only trade.

Common Themes

Of those submitters who supported the proposed policy, religion was a common theme, expressing the sentiment that the minority of the population is religious and therefore business owners should be able to trade if they want.

In addition to this, submitters in support of the proposal noted that businesses have had to close during recent lockdowns and feel that businesses should be able to trade if they wish to, to assist in recouping losses due to COVID-19 impacts.

The key theme for those who did not support the proposed policy and wish for shops to continue to close was for the wellbeing of the business owners and workers, to ensure workers and owners are given a chance to be with their families and to rest.

5.1 Options

Ngaa koowhiringa

Staff have assessed that there are two reasonable and viable options for the Community Committee to consider.

Option 1 – Adopt the proposed Easter Trading Policy which enables shops to open on Easter Sunday if they wish to.

Option 2 – Revoke the current Easter Trading Policy which will prohibit most retail shops from opening on Easter Sunday. The Shop Trading Hours Act 1990 details exceptions where shops can open on Easter Sunday regardless of whether Council has a policy. These shops are included in Attachment 4.

5.2 Financial considerations

Please note, as you are likely already aware, David Whyte has many hats he wears. Therefore it is emphasised that this a personal submission and does not represent any of the boards or committees that he is involved with.

We support option 3 – revoke the policy. Thus limiting trading on Easter Sunday. The simple reason is that there are 365 days in a non leap year. Of these, 362.5 days shops currently have no restrictions on opening. These 2.5 days are Christmas, Good Friday, and half a day on ANZAC. With going for option 3, this would add an additional day resulting in 361.5 days that full trading is allowed.

So the days with restrictions on trade go from 0.68% of the year to 0.96% a seemingly rather trivial increase in the days with restrictions.

We notice two groups of people seem to support trading on statutory holidays. These are

a) White collar workers. These workers already get most weekends off to do the recreational spending that they wish to do. So they already have lots of options. What is interesting is that white collar works are not the business that are opening on statutory holidays. Thus folks who don't work in retail / hospitality are wanting service. But they are not personally impinged by the changes as they don't work in the industries that are open.

Also white collar workers are empowered, they understanding how systems work and how to lobby thus their voices can be loud and clear.

b) Business owners or corporations. These business owners and corporations stand to gain from having their business doors open on Easter Sunday. Since they wish to increase their profit. This is all fine and dandy however the owners and corporations don't typically actually work that day. Their workers work that day. If they do work they are not on the minimum wage. The other workers do not have shares in the business / profit sharing, therefore their only recompense is the wage they draw.

Again these groups of people are very outspoken and know how to play the game to their benefit.

Thus the supporters of the policy are not the ones who have to pay the price for it. This falls to those who are typically on low / minimum wages. These are generally folk who are either young, older, don't have strong education, or limited employment options. Thus they are at an inherent disadvantage. They might not have the skills to speak up, and if they do they are likely to face repercussions that can have massive impact.

Therefore these voices are effectively silenced. Also this group of folks often work long hours and lack the time with whanau and re-charge time. Thus raising a flag regarding mental health. We know that constant work isn't healthy for body or mind. Yet our headlong rush into opening nearly every day of the year the health impacts to those forced to work hasn't be taken into consideration.

We also take note that option 3 still allows folks to have their latte, visit the garden centre and pop down to the 4 square for the box of beers that they suddenly require. So it is hardly a massive impingement upon average everyday folks.

So to conclude we support option 3 and think WDC should do also.

1 Introduction

- 1.1 This policy is made under Part 2 (subpart 1) of the Shop Trading Hours Act 1990 (Act) which provides Council with the ability to establish a local policy to enable shop trading on Easter Sunday.

2 Purpose

- 2.1 The purpose of the Local Easter Sunday Shop Trading Policy (Policy) is to enable shops to trade on Easter Sunday if they wish to. The Policy neither requires shops to open, or individuals to shop on Easter Sunday.

3 Significance

- 3.1 The review of this Policy could trigger the Significance and Engagement Policy due to significant community interest.

4 Application

- 4.1 This Policy applies to the shops trading in the Waikato District area.

5 Policy Statements

5.1 Shop Trading Locations

- 5.1.1 Shop trading is permitted throughout the Waikato District.

5.2 Exemptions

5.2.1 This Policy does not:

- a) Apply to any day other than Easter Sunday.
- b) Control the types of shops that may open, or their opening hours.
- c) Limit Council's ability to undertake its duties, powers or functions under any other Act (i.e. the regulation of the Sale and Supply of Liquor).
- d) Address shop employee rights, which are governed by the requirements of the Act. For the avoidance of doubt, shop employees have the right to refuse to work on Easter Sunday as per the Act.

5.2.2 Council is not responsible for the enforcement of this Policy. Enforcement is undertaken by the central government department that is responsible for the administration of the Act.

5.2.3 Certain shops may open as per Part I Section 4 of the Act.

What shops can open on Easter Sunday?

The table below is an extract of information (available from www.employment.govt.nz) shows those shops that are able to open regardless of whether Council adopts a policy or not. The shops below are exempt under the Shops Trading Hours Act 1990.

Is the shop a...	Then they can open so long as...	Conditions
Service station	The only goods they sell are: <ul style="list-style-type: none"> • Food • Drink • Household items • Personal items • Petrol, oil, car parts and accessories. 	The goods they sell are items people can't put off buying until the next day, such as baby formula or pet food, and the number of goods for sale is no more than needed to meet the needs of people in the area.
Take away bar, restaurant, cafe	They only sell prepared or cooked food ready to be eaten immediately in the form that it is sold.	
Duty free store	They are only selling duty free items.	
Shop providing services, rather than selling goods, such as a video rental store or hairdresser	They only provide a service, such as renting videos or cutting hair.	They don't sell any goods, such as videos or hair products.
