POKENO COMMUNITY COMMITTEE SUBMISSION ON GULL PROPOSAL

Reasons For Opposing (not in priority order)

- No Need for Additional Fuel Stations. There are currently two fuel stations on Great South Road, Pokeno: GAS (primarily for private and smaller vehicles and LPG) and a Z Truck Stop. Accepting that a GULL station is likely to result in increased competition (especially relating to the GAS station prices), probably lower fuel prices and increased convenience resulting from a 24-hour operation, the Pokeno community has no need for a third fuel station on its main thoroughfare and in this location. The Pokeno Community Committee has no objection per se to a GULL Station in Pokeno but not in the location specified in the current proposal.
- 2. **Inconsistent with Vision and Plans.** A fuel station on the proposed site does not meet the intent and vision for Pokeno outlined in a number of key documents the majority of which have been derived following extensive public consultation. These include:¹
 - a. Parts of the *Waikato District Plan* such as Chapter 18: Business Town Centre Zone. Especially Rule 18.2.2 Servicing and hours of operation; 18.2.3 Glare and artificial light spill and 18.2.5 Hazardous substances.
 - b. Appendix 10.4 to the *Waikato District Plan*: Pokeno Town Centre Character Statement. When read in its entirety, it is clear that a fuel station in or on the fringes of the Pokeno Township does not fit with the Character Statement.
 - c. Waikato 2070 and especially:
 - i. Page 15, 04.2 Pokeno Development Plan and page 16, 04.3 Pokeno Town Centre Plan where the proposed site sits on the fringes of the Town Centre and commercial activity zones.
 - d. *Waikato Blueprint 2019*, pages 66-67: 4.2 Pokeno. A significant comment derived from the consultation for this document was "The truck stop, while it is contributing to Pokeno, causes amenity issues for the town centre." It can be inferred from this that another fuel station in or adjoining the town centre will elicit a similar concern from Pokeno residents.
 - e. *Pokeno Town Centre Architectural Form, Material and Signage Design Guide.* Adopted by the Waikato District Council in September 2015, and reflecting community consultation, this documents reflects how the Pokeno Town Centre should be developed in terms of 'look and feel' and provides a Concept Guide for Pokeno's Market Square
- 3. Pokeno is Growing. Pokeno is growing rapidly with some predictions pointing to a population approaching 20,000 which would make Pokeno one of the largest towns in the Waikato District. One of the challenges facing the Council, Community Committee and residents is managing that growth in a way that results in a town that is well-planned and which reflects the desires of its residents. It is and will continue to be a strategically important area, at the junction of SH1 and SH2 and the northern gateway to the Waikato. It is therefore critically important that Pokeno and especially the 'heart' of Pokeno (the town centre/Market Square) is developed in a way that is consistent with the already well documented views of Pokeno residents. It must

¹ It is acknowledged that the proposed site might not sit fully within current business/commercial zone or the Market Square boundaries. However, it is on the fringe of these areas and so activities carried out on this site are certain to impact on these zones and plans.

not be allowed to continue to develop in the ad hoc way it has to date. Business and commercial growth is encouraged but in areas which are clearly designed and ear-marked for such activities.

4. Traffic Management and Safety.

- a. We contend that the Traffic Impact Assessment by Traffic Solutions Ltd (Appendix 3 to the Gull submission) is flawed. Traffic volumes along Great South Road in this report are based on 2015 council traffic counts of 3,995 per day which the traffic engineer has estimated will have increased to around 4,500 per day. No updated accurate data was provided and it is not clear from the proposal where the traffic counter was situated on Market Road East to count the 40 vehicles per day that has been alluded to. For instance, did this count also include the vehicles accessing the existing GAS station though the Market Road slip lane? There is considerable scope for underestimating the traffic volumes experienced and indeed the Pokeno Community Committee is of the view that traffic volumes along Great South Road Pokeno have increased substantially. Developments in Tuakau have led to higher volumes of traffic entering Pokeno from the west and the new Countdown supermarket in Pokeno has certainly generated significantly more traffic².
- b. The peer reviews of the Traffic Impact Assessment and especially the Addendum dated 26 November 2020 and the Memorandum dated 15 December 2020 cast significant doubt on the safety and practically of locating a fuel station on the site. The November addendum raises some serious concerns regarding sight lines and traffic flow concluding in part that "Without mitigation, these potential safety effects would be unacceptable." The review also raises concerns around:
 - i. Pedestrian safety even to the point of recommending the War Memorial be moved (something the Pokeno Community Committee and residents would adamantly oppose).
 - ii. The proposed signage, fencing and hedging.
 - iii. Traffic movement into, out of and within the proposed site.
 - iv. Queuing traffic, especially on days where fuel discounts are offered, will be a hazard with increased likelihood of vehicle accidents occurring.
- c. It must be noted that the impact on traffic movement following the opening of the new supermarket appears not to have been factored into the proposal or the traffic plans.
 The Pokeno Community Committee, through direct observation, feels that traffic volumes have increased markedly. As the town grows, so will these volumes.
- d. There has already been a notable increase in heavy traffic movement at the Pokeno Road/Great South Road intersection. The planned widening of Pokeno Road does not include this intersection and while there has been discussion around placing traffic signals at this intersection (as noted by the traffic engineers), there are as yet no firm plans or time frames for this to occur (if it does); though there are plans to close Ford Street to through traffic which will result in all traffic having to transit this intersection. Given that this is a major intersection and that the distance from the proposed Gull station and sight lines from it to this intersection are below the recommended distances, this is likely to result in significant traffic issues, especially on days of increased volumes to the proposed fuel station (such as fuel discount days).

² These are based on observations rather than an actual count but are probably more accurate that the estimates made by Traffic Solutions Ltd. The Pokeno Community Committee has already requested that Council review the traffic flow around and through Pokeno.

- e. On the issue of pedestrian safety, it is the view of the Pokeno Community Committee that the impact of a fuel station at the proposed location would adversely impact pedestrian safety especially that of the young and the elderly. The proposed location, close to the major intersection of Pokeno and Great South Roads, is already a major pedestrian thoroughfare for those going to and from the shopping precinct and the Pokeno School. The additional traffic movement and especially the impact of reduced sight lines as described by the traffic peer reviews would exacerbate this.
- 5. Trees. One of the recommendations contained in the proposal was the recommendation to remove or severely trim the trees to improve sight lines. These trees were planted as part of the Beautify Pokeno programme to enhance the look and ambience of the area not for developers to trim or remove them if the developer felt they were unnecessary. Additionally, we are of the view that these trees are designated as Notable Trees by the Waikato District Council. Therefore, the Pokeno Community Committee strongly opposes any action that would remove or seriously deplete these trees. Given the trees location in the area of the war memorial, it is useful to point out that 300 or more people attend ANZAC services at the memorial and of course, these attendees also cross the Great South Road to attend this service and to attend the subsequent morning tea at the Pokeno Hall.
- 6. Public Opinion. On Sunday 21st February, members of the Pokeno Community Committee set up a stand at the Pokeno Market from 8.00 am to 12 noon. Market attendees were asked if they supported, opposed or were neutral on the proposal. Where necessary, the proposal was explained to them in outline and the Summary of Application was made available for them to read. Committee members indicated the Committees position on the proposal if asked. 160 individuals recorded their opinion. Of these, 49 identified as Pokeno residents by address. In total, 9 supported the proposal, 4 were neutral and 147 opposed the proposal. No Pokeno residents supported the proposal though two were neutral. The remaining 47 opposed it. The original sheets recording this information are available if required.

SUBMISSION FOR THE GULL PROPOSAL IN POKENO

Reasons For Opposing this proposal:

1/ Fuel Stops presently in Pokeno main street:

We have currently Pokeno GAS for private vehicle use and a Z Truck Stop all within metres of the proposed Gull Station. The traffic utilizing both of these places is already on the higher side. Placing another competitor within metres of both of these fuel stops and with the GULL station operational 24 hours, 7 days a week this will increase considerably.

We are not opposed to having competition for Petrol services in Pokeno however we are opposed to the current proposed position of the GULL Fuel stop in Pokeno in the current proposal.

2/ Market Square Future Plans:

A very robust discussion with plans and the future vision for the Pokeno main street has been worked through by the Pokeno Community Group. The Pokeno Community was consulted and this was discussed at many community meetings. One agreed upon this was then shared with the Waikato District Council for future plans. This was an exciting and fitting plan for Market Square right next to where the Gull Station is proposed. As the Gull station is not on Market Square proposed plans it however will affect the clear vision the Pokeno Community have for this.

The Centopah which is a memorial to our fallen heroes is sitting on the edge of this new proposal along with the very large old Oak Trees. With the new development of this site we feel this will most definitely affect our future plans for this area.

The very old Oak trees could possibly have to be removed with this huge development. In the proposal there are plans to remove or severely trim the trees to improve sight lines. If they were not removed the digging to create large pits for petrol tanks to be placed underground will most definitely affect the root system of these old trees and will kill them over time. Trimming them to suit the proposed new GULL site we are definitely opposed to.

The Centopah is a main feature in Pokeno and where the development of market square was going to make this a focal point. On Anzac Day every year we have 100s of people gathering at this site to honour our fallen comrades. We are extremely opposed to this area a huge part of the history of Pokeno being overlooked to allow a Gull fuel stop.

We have supplied the facts from the Waikato District Council regarding Market Square.

Below are facts supplied to Waikato District Council.

Inconsistent with Vision and Plans. A fuel station on the proposed site does not meet the intent

and vision for Pokeno outlined in a number of key documents – the majority of which have been

derived following extensive public consultation.

These include:

a. Parts of the Waikato District Plan such as Chapter 18: Business Town Centre Zone.
 Especially Rule 18.2.2 Servicing and hours of operation; 18.2.3 Glare and artificial light
 spill and 18.2.5 Hazardous substances.

b. Appendix 10.4 to the Waikato District Plan: Pokeno Town Centre Character Statement.When read in its entirety, it is clear that a fuel station in or on the fringes of the PokenoTownship does not fit with the Character Statement.

c. Waikato 2070 and especially:

i. Page 15, 04.2 Pokeno Development Plan and page 16, 04.3 Pokeno Town Centre
 Plan where the proposed site sits on the fringes of the Town Centre and
 commercial activity zones.

d. Waikato Blueprint 2019, pages 66-67: 4.2 Pokeno. A significant comment derived from the consultation for this document was "The truck stop, while it is contributing to Pokeno, causes amenity issues for the town centre." It can be inferred from this that another fuel station in or adjoining the town centre will elicit a similar concern from Pokeno residents.

3/ Traffic Management and Safety.

With increased traffic utilizing the proposed GULL Fuel Stop this is of a huge concern to the safety of pedestrians and also the large number of cars exciting the proposed site and crossing Pokeno Road. The increase in traffic with the new Countdown has already caused a lot of stressful situations with cars crossing over Pokeno Road. The Z Fuel stop with the large trucks entering and exciting this spot only ads to the congestion already in the main street.

Below is the Traffic Management and Safety the Pokeno Community Group discussed. They have the knowledge and information. We agree with every point they have made about this.

1. Traffic Management and Safety.

1. We contend that the Traffic Impact Assessment by Traffic Solutions Ltd (Appendix 3 to the Gull submission) is flawed. Traffic volumes along Great South Road in this report are based on 2015 council traffic counts of 3,995 per day which the traffic engineer has estimated will have increased to around 4,500 per day. No updated accurate data was provided and it is not clear from the proposal where the traffic counter was situated on Market Road East to count the 40 vehicles per day that has been alluded to. For instance, did this count also include the vehicles accessing the existing GAS station though the Market Road slip

lane? There is considerable scope for underestimating the traffic volumes experienced and indeed the Pokeno Community Committee is of the view that traffic volumes along Great South Road Pokeno have increased substantially. Developments in Tuakau have led to higher volumes of traffic entering Pokeno from the west and the new Countdown supermarket in Pokeno has certainly generated significantly more traffic.

- 2. The peer reviews of the Traffic Impact Assessment and especially the Addendum dated 26 November 2020 and the Memorandum dated 15 December 2020 cast significant doubt on the safety and practically of locating a fuel station on the site. The November addendum raises some serious concerns regarding sight lines and traffic flow concluding in part that "Without mitigation, these potential safety effects would be unacceptable." The review also raises concerns around:
 - 1. Pedestrian safety even to the point of recommending the War Memorial be moved (something the Pokeno Community Committee and residents would adamantly oppose).
 - 2. The proposed signage, fencing and hedging.
 - 3. Traffic movement into, out of and within the proposed site.
 - 4. Queuing traffic, especially on days where fuel discounts are offered, will be a hazard with increased likelihood of vehicle accidents occurring.
- c. It must be noted that the impact on traffic movement following the opening of the new supermarket appears not to have been factored into the proposal or the traffic plans. The Pokeno Community Committee, through direct observation, feels that traffic volumes have increased markedly. As the town grows, so will these volumes.
- d. There has already been a notable increase in heavy traffic movement at the Pokeno Road/Great South Road intersection. The planned widening of Pokeno Road does not include this intersection and while there has been discussion around placing traffic signals at this intersection (as noted by the traffic engineers), there are as yet no firm plans or time frames for this to occur (if it does); though there are plans to close Ford Street to through traffic which will result in all traffic having to transit this intersection. Given that this is a major intersection and that the distance from the proposed Gull station and sight lines from it to this intersection are below the recommended distances, this is likely to result in significant traffic issues, especially on days of increased volumes to the proposed fuel station (such as fuel discount days).
- e. On the issue of pedestrian safety, it is the view of the Pokeno Community Committee that the impact of a fuel station at the proposed location would adversely impact pedestrian safety – especially that of the young and the elderly. The proposed location, close to the major intersection of Pokeno and Great South Roads, is already a major pedestrian thoroughfare for those going to and from the shopping precinct and the Pokeno School. The additional traffic movement – and especially the impact of reduced sight lines as described by the traffic peer reviews - would exacerbate this.

These are based on observations rather than an actual count but are probably more accurate that the estimates made by Traffic Solutions Ltd. The Pokeno Community Committee has already requested that Council review the traffic flow around and through Pokeno.

Reasons for Opposing:

1. Light Pollution

Gull 24-hour service stations are lit during night-time hours. Our family home at 73 Great South Road is adjacent to this site, and the site has line of sight from three (3) rooms in our home, two (2) of which are bedrooms. This is inconsistent with quiet enjoyment of our property. Please see picture 1, 2, 3 attached for light examples from the Gull Site at Tuakau.

2. Traffic Management and Safety.

We believe traffic estimates contained within the submission are not consistent with reality, particularly since the opening of Countdown Pokeno.

- a. The junction of Pokeno Road and Great South Road experiences congestion due to southbound traffic turning right into Great South Road and would be further impacted by any traffic turning into the proposed Gull Station. Furthermore, northbound traffic turning left into the proposed Gull Station, would need to queue further because of traffic flow. This is particularly prevalent during the school rush (8am-9am & 2:30pm-3:30pm), which also coincides with an increase of children walking through this area. Should raised medians be used, what consideration has been given to northbound traffic where will they attempt to U-Turn in order to access the site? This can only be only heavily trafficked sections of Pokeno/Great South Road.
- b. No consideration is offered for pedestrians coming into Town Centre, and as a family with young children who attend Pokeno School, this area is already hostile to pedestrians, and would be exacerbated by the proposed development.
- c. The roading surface along Great South Road (through the Town Centre), and along Pokeno Road (up to Helenslee Road) is substandard due to heavy traffic flows currently. There is no indication that this would improve with increased traffic.
- d. In a time where towns across New Zealand are taking steps to divert traffic away from Town Centres, decisions for Pokeno appear to be focus on increasing industry and private traffic. We <u>strongly oppose</u> activity that prioritises traffic over people.

3. Increased risk to traffic incidents

- a. We have personally witnessed traffic incidents due to poor design and poor driving at the intersection of Great South Road and Pokeno Road (always southbound right turning traffic)
- b. In December 2019 a medical event resulted in a heavy transport vehicle colliding into 3 properties along this intersection. Our property at 73 Great South Road, was the most heavily affected, with substantial property destruction, and heavy contents loss. This created significant trauma for our family. Whilst such events cannot be anticipated, we strongly oppose increased heavy traffic (as per point 2.d)
- <u>No Need for Fuel Stations in this location</u> There are currently two fuel stations on Great South Road, a GAS and a Z Truck Stop (which is entirely in the wrong place for a community the size of Poekno). 24-hour Service Centres are located 5 minutes in either direction (Bombay & Mercer) along SH1.
- 5. **Inconsistent with Pokeno Vision and District Plans.** Across Waikato District Plan and Blueprints, along with presentations made to the Pokeno Community, the intent was to beautify the town centre with a focus on non-vehicle traffic. Market Square was referenced as a key part of this

beautification. This development not only removes the opportunity in this location, but such commercial/industrial activity sets a precedent for what the Town will look like to visitors.

6. Potential removal of House Trees & Memorial.

- a. One of the recommendations contained in the TRANSPORT PEER REVIEW ADDENDUM was the recommendation to remove or severely trim the trees to improve sight lines, and to potentially relocate the Pokeno War Memorial. We vehemently **<u>oppose</u>** any business or development influencing the removal of these key treasures.
- Both dwellings at 68 & 72 Great South Road appear to be original building from Pokeno's early development, in particular 72 Great South Road. In fact, visitors often comment on 72 as an amazing historical house. Such a site would seem to be an ideal place to showcase Pokeno's rich history.
- 7. Local Impact It is our opinion that whilst the proposed site might be zoned for this type of development, it fails to take into account that this area is predominately a residential area, with short- and long-term residents and families who are impacted by all of the above. Furthermore, an unmanned service station offers no local employment opportunities or benefits to the community, outweighing the commercial benefits to Gull.


In Summary we have no objection to a GULL Station in Pokeno but strongly oppose the location specified in the current proposal.



At the centre of the village is the Council owned land at the Market Square, located at the intersection of Great South Road with Market Road. It is anticipated that Great South Road will remain as a significant traffic route; it has been determined that a bypass is not a viable option.

There is strong community sentiment to protect the 'village feel' of the main street area.

The existing square is currently formed by four areas of land separated by the roads with no common use or theme extending accross them. Visitors to the village do not read them as a single space.

Boffa Miskell prepared a high level concept for the land as part of the Pokeno Town Centre Strategy (2008).

This report studies the context of the Market Square within the wider village, identifies opportunities for its upgrade and provides an assessment of the Boffa Miskell option and a newly developed option for consideration and comparison.

It is intended that the report and options be presented to Councillors prior to public consultation taking place.

2. Council Workshop 28 May 2013

At the Council Workshop on the 28th May 2013 a number of 'Drawcards' were identified. For the Market Square these were:

Reinstate Market Square as the civic focus:

- ✓ Potential to reclaim part of the wide road for the square
- \checkmark *Consider whether feasible to create concourse by* excluding traffic from that part of Great South Road which presently dissects this public asset
- ✓ Accentuate historic significance of cenotaph
- ✓ Create recreation space and amenity in town heart with playground/rest area/trees
- ✓ Make available for community events/farmers' markets
- ✓ Consider relocation/refurbishment of existing public conveniences

An earlier option for the redevelopment of the Market Square which had been produced as part of the Pokeno Town Centre Strategy had received significant local support.

This study seeks to identify the most appropriate means to achieve these aspirations.






Figure 3: Illustration of earlier option for redevelopment of Market Square

Top Left: Heavy vehicles use Great South Road. Many use existing facilities including the truck stop, motel, shops and cafes.

Top Right: Significant additional commercial development is taking place in the village. This is likely may lead to additonal traffic using Great South Road. It is also likely to increase the number of workers and residents wishing to use the facilities in the village centre.

Bottom Left: Entrance to village from the South; wide streets with spaced out development.









Top Left: The Market Square (centre of top photograph) has direct road linkage to the site of the potential passenger train station and park/ride site. This is a short walk.

Top Right: There are a number of exisitng businesses on the Great South Road, including the Truck Stop, Motel, Liquor Store and Country Cafe (as shown). There is also a superette, petrol filling station and takeaways.

Context Appraisal, Key Matters:

- The village is undergoing significant change
- New business developments are taking place in the south of the railway line -
- The village adjoings the main North Island Trunk Line; the potential train station would provide easy access to Auckland for Commuters -
- Users of SH1 can easily use village facilities as there are entrance ramps at the northern and southern extent of the village; the route along Great South Road between these is only 1500m -
- There is a significant network of Paper Roads; these must be retained -
- The formed roads and paper roads together form a very well connected and legible grid network -
- Great South Road passes through the centre of the village. It is of significant heritage interest being the key route from Auckland to the Waikato. Construction begain in 1861 during the New Zealand Wars to secure the flow of supplies to troops. Following the war it became the main social and commercial link to Auckland.
- Existing Commerical uses are centred around Great South Road and form the heart of the village. These are very close to Market Square. -
- The existing commercial uses shape residents/visitors image of the area; Pokeno Bacon and Pokeno Ice Cream Shops. It is imporant that these uses are maintained. -
- -The existing Market site has potential development value; the market may threfore need to relocate
- Market Street, which joins Great South Road in the Square is a key access to the potential train station -

Site Appraisal Key Matters:

- Site is subdivided into four quadrants by roads
- Great South Road is well used by vehicles; use may increase with additonal development
- Scheduled trees in northern quadrant are very important local landmark. Appear to require some husbandry.
- Cenotaph is an important local landmark; currently on island between roads. Setting could be improved.
- Potential for reuse of adjacent historic cottage to extend onto space under trees; eg outside seating etc if it was used as a cafe
- Slope of land to the west creates opportunites and constraints that design must consider
- Good existing pedestrian links from Square to shops
- Existing diesel pump and tank is a significant constraint with potential costs to remove and reinstate (although cost may be responsibility of leaseholder)
- Installation of reticulated sewage in the village will allow the removal of the septic tanks

6. Options

Option 1; 'Village Green'

Key Matters:

- New lane around outside of square impacts on potential ability to retain existing trees
- Improves setting of Cenotaph
- Still necessary to retain Great South Road access/through route for traffic; however this respects historic alignment of the road
- Must remove diesel tank and pump
- Reduces parking available for hall
- Creates good focus for village
- Could relocate market to the space however would not be an ideal all year venue that could compete with other markets sited in permanent structures on hard sufaced land (eg Clevedon)
- Does not address current sloping land
- Unless modified would require removal of hall extension; modified design could have greater impact on existing trees
- Does not create area that could be used in conjunction with historic cottage if this changes use.
- Does not create area that could be used in conjunction with residential building adjoining south eastern boundary if this changes use
- Could be taken ahead of other main street improvements (but does require alterations to toilets, hall and diesel tanks/pump)
- Maintains north and south routes out of square; however route to potential train station not as clear/easy as existing



Option 2; Preferred Staged Development 'Multi-Use Square'

Key Matters:

- Can be brought forward in stages; opportunity to upgrade setting of Cenotaph prior to 2015 100th Anniversary of ANZAC Day.
- Provides all year venue for the market should this relocate by providing hard surfaced area and some permanent stalls (which shield views of boundaries of the square)
- Addresses sloping land by introducing retaining slopes and walls and creates lower level areas
- Creates an area that could be used in conjunction with historic cottage should this undergo a change of use
- Creates an area that could be used in conjunction with residential building adjoining south eastern boundary if this undergoes change of use
- Allows retention of exisitng toilets and open up views of these (CPTED benefits)
- Improves setting of Cenotaph
- Community Hall does not require modification
- Area adjacent to community hall can still be used for parking, but is also capable of other uses, including temporary market stalls
- Area adjoing toilets could also be used for market stalls
- Historic alignment of Great South Road and original Pokeno grid street network still clear to see
- Could be taken forward independent of other 'main street' improvements
- Maintains easy access to potential train station with dedicated route through the square.
- Recognises lower traffic flows to north and allows this to be part of shared space
- Can utilise afforbable materials
